Legal license of organization in Directorate of Kurdistan non-governmental organization (NGO)s Registration No. (134 - G) date of Issuance of Registration Document: 26/03/2013

The most important activities of the organization in 2024

In 2024, our organization carried out many diverse projects and participated in various activities, which are as follows:

1- On January 6, 2024

A general assembly meeting of the organization was held with the attendance of its members. During the meeting, the organization's annual report for the year 2023 was presented and discussed with the members. A unanimous decision was made during the meeting to change the organization's name from "Organization for Gender Studies and Information" to "ROZA Organization for the Protection of Women and the Environment".

2- On January 9, 2024

As part of the project to promote minority rights in Iraq, and with support from NPA (Network for the Protection of Minorities), a one-day workshop was held in collaboration with our organization for 25 partner organizations within the Minority Alliance Network. The workshop focused on monitoring institutional development among the partner organizations. A development plan for civil society organizations was prepared, along with a sustainable institutional development plan. The needs of the partner organizations were identified, to be addressed throughout the year 2024.

3- On February 10, 2024

A general assembly meeting of the **Kurdistan Women Defenders Alliance** was held in Duhok Governorate, attended by Dr. Khanzad Ahmed, Secretary General of the High Council for Women and Development, along with the participation of several activists and academics from Duhok. During the meeting, the 2023 activity report of the alliance was presented, along with an evaluation of the

alliance's performance, aimed at identifying strengths, weaknesses, and strategies for sustaining and advancing the alliance.

The meeting also included discussions on the role of women in combating violence, as well as the challenges and risks faced by women in general.

At the conclusion of the meeting, the following key proposals and recommendations were presented:

- 1. The alliance should hold a meeting as soon as possible with women politicians and activists in Kurdistan to develop an action plan for addressing the risks and challenges facing the Kurdistan Region.
- 2. Women should be included in meetings, sessions, and delegations between the Kurdistan Regional Government and the Federal Government of Iraq.
- 3. Serious efforts must be made to conduct elections in Kurdistan to address the legal vacuum caused by the delay and to protect the democratic process in the Kurdistan Region.

A visit was conducted to the Women and Juvenile Reformatory in Erbil to carry out the initial survey on the conditions of reformatories in Iraq, as part of the project "Promoting Human Rights in Iraqi Prisons."

During the visit, a meeting was held with Mr. **Tayeb Abdulaziz**, Director of the Women and Juvenile Reformatory in Erbil, as well as with **Public Prosecutor Judge Kazhal Naif**, and representatives from the Health Center Department, the Monitoring and Planning Department, and the social worker at the facility. The survey generally addressed the conditions of sentenced and detained individuals, the number of staff, the state of the reformatory building, and the overall challenges and problems faced by the institution.

7- On August 9, 2024

Participation in the **Conference on Combating Violence Against Women** held at the Conference Palace in Baghdad, organized by the Hikma Movement. The event was attended by Mr. Ammar al-Hakim, Mr. Mohammed Shia' Al Sudani, and Ms. Taif Sami, Minister of Finance, along with ambassadors, prominent figures, and activists from across Iraq.

The conference highlighted methods to protect women from violence and the mechanisms for implementing laws that safeguard families in general and women in particular.

8- On August 19, 2024

Our organization, as a founding member of the Kurdistan Women Defenders Alliance, together with Ema Organization for Human Development and a group of activists, participated in a gathering and press conference opposing the amendment of Personal Status Law No. 188 of 1959.

The amendment was condemned and rejected because it poses a serious threat to the rights of women in Iraq and Kurdistan in general, and to the rights and future of children in particular. It facilitates early child marriage, deprives children of continuing their education, and causes numerous social problems. The event called on the Iraqi government and the Council of Representatives not to vote for the amendment but instead to draft a new law that guarantees equality and justice for all without discrimination, supporting the rights of women, families, and children.

A training course for election observers was conducted in Koysinjaq District, where 8 young men and women volunteers from the district were trained to monitor the Kurdistan Parliament elections.


14- On October 20-21, 2024

The amendment was described as a significant challenge to the rights of women in Iraq and the Kurdistan Region. The proposed changes to the law in its current form pose a threat to society as a whole and particularly to women
